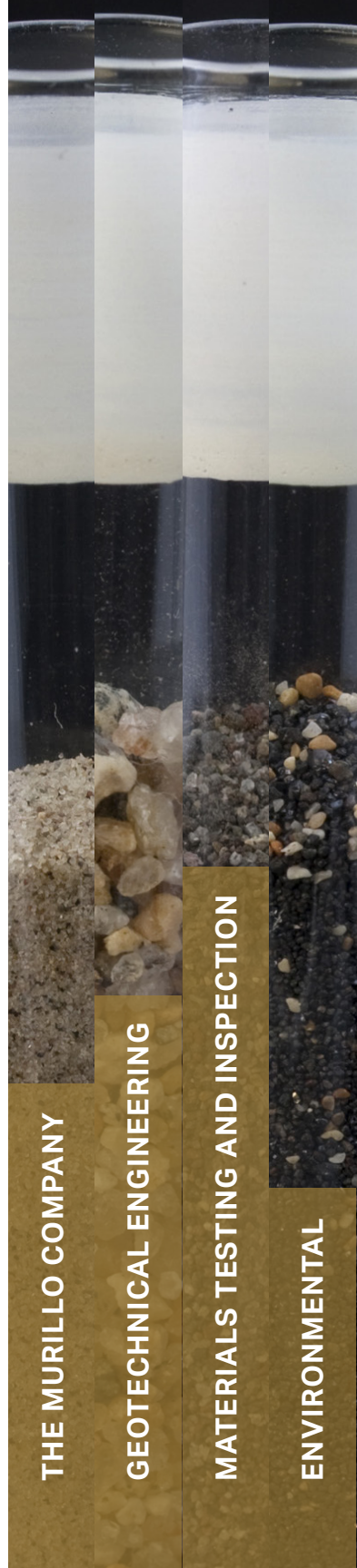

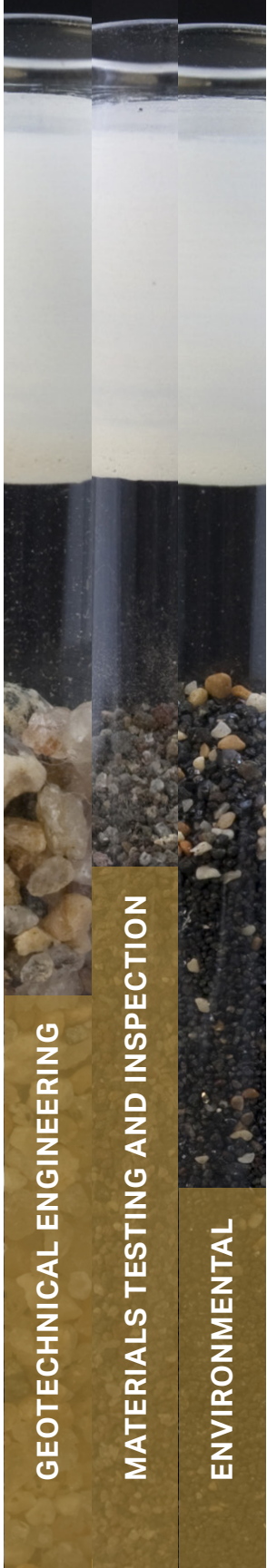
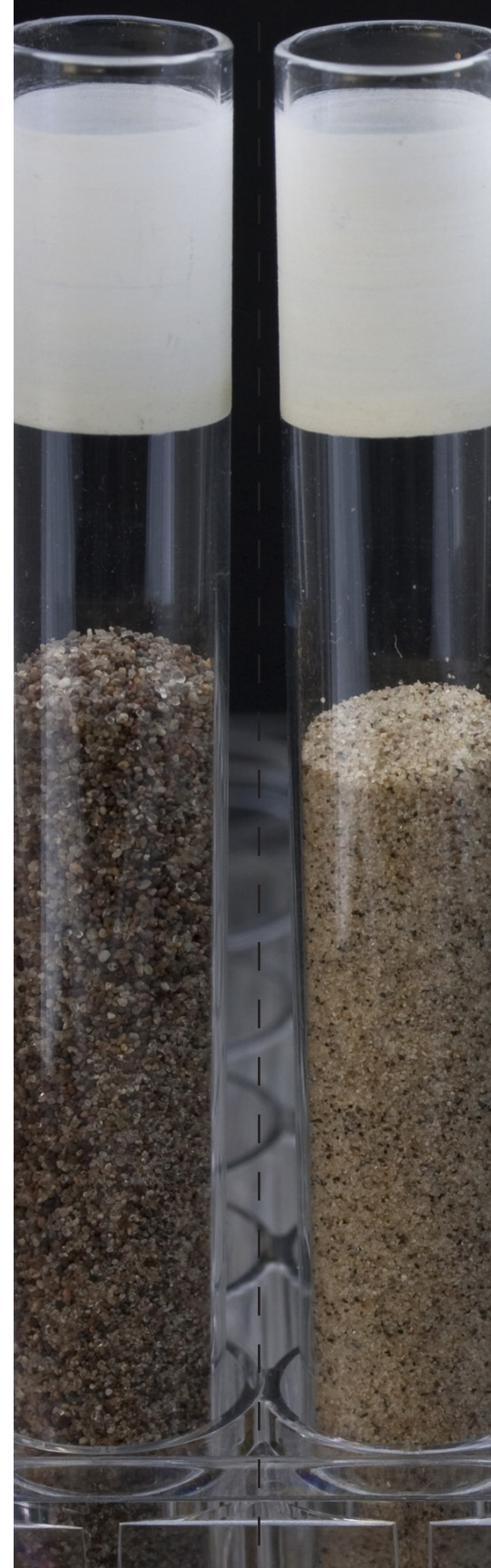

Upon completion of our investigation, we promptly provide our clients with clear and precise reporting of field inspection and testing results.

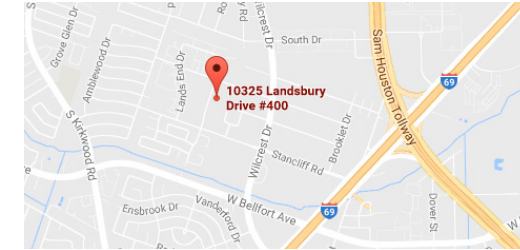
